

General Rules and Regulation Aruba Ports Authority N.V.

1. Maximum speed limit 20 Km/h.
2. Unauthorized access is prohibited.
 - *The access to the harbors of Oranjestad and Barcadera is prohibit for unauthorized persons.*
 - *The Aruba Ports Security is entitled to search persons, vehicles, and items coming into or out of the port facility.*
3. Entrance is at your own risk.
 - *Aruba Ports Authority N.V. is not responsible for any personal injuries or any stolen, damages personal material.*
4. Access provided is for authorized area(s) only.
5. Unannounced guests to the harbors of Oranjestad and Barcadera are prohibited.
6. Vehicle are allowed into the Harbors area only if absolute necessary.
 - *Vehicles without a permanent or temporary pass are not allowed into the port areas. A request must be sent to security by the responsible person for a temporary vehicle access pass.*
7. Anyone is obligated to identify themselves when requested by the Port Security.
8. Games and gambling on Port areas is strictly prohibited.
9. For the security control all vehicles entering the premises will have to drop off their passengers, the passengers will be using the pedestrian walkway to enter and leave the premises. (Exceptions: Tourist in Taxi and Tour busses, for these other rules and regulation are applied)
10. Anyone who is located in the harbor areas is responsible for maintaining order and safety. Misbehavior, unnecessarily noisy, to be annoying and troublemakers are not tolerated.
11. Employees that are not scheduled to work are not permitted to be on the Port property. (Exceptions: only with a written request from the Department head).
12. Everyone It is strictly forbidden to:
 - *Consume alcoholic beverages and / or the use of drugs, or to be under the influence of these agents within the port facilities. APA has the right to test all visitors on its premises for drug and alcohol usage.*
 - *Fishing, swimming and or diving*
 - *Make any pictures and or filming without written permission of the Port Management.*
 - *To import, export, and carry or to possess any illegal drugs, firearms, ammunition or any explosive device or material on port premises.*
13. Any person who has caused or is involved in an accident on one of the port premises will be submitted to a drug and alcohol test. The person will not be permitted to leave the harbor until the drug and alcohol test is performed. (Not cooperating is consider as failure for this test)
14. It is prohibited to possess, request and or accept, store and or to deal or exchange of other goods for alcohol from the crew or Captain of any vessel.
15. Lewd and/or obscene language, bad behavior or not following security instructions is NOT TOLERATED by Port Security.

It is the responsibility of all persons to subject and adhere to these rules and regulations. Not complying with these rules and regulations will result in expulsion of the Port premises and / or revocation of their access badges.
